**Sub: Update to earlier disclosure of Litigation as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

In continuation of our earlier disclosure dated August 17, 2023, regarding material tax litigations pertaining to Service Tax matters for the financial years 2004-05 to 2008-09, 2009-10, 2010-11 and 2011-12, wherein we had informed that the Hon'ble Supreme Court, vide its order dated August 14, 2023 (received on August 16, 2023), in relation to the levy of Service Tax amounting to ₹86.42 crores pursuant to an order passed by the Service Tax Department, had set aside a demand of ₹51.24 crores (out of the total amount of ₹86.42 crore) on the ground that the classification mentioned in the show cause notice under “**Management, Maintenance and Repair Services**” was erroneous, and the remaining matter was remanded to the adjudicating authority for reconsideration, we now wish to provide the following update:

Pursuant to the directions of the Hon'ble Supreme Court, the case was taken up for *de novo* adjudication. The Principal Commissioner, CGST & CX, Belapur, has since passed a partially favourable order reducing the net service tax demand to ₹5.59 crores, along with applicable interest and penalties under Sections 73(2), 75, and 76 of the Finance Act, 1944.

The aforesaid order was received by the Company on November 11, 2025, at 3:07 p.m.

Details required as per the SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, is annexed as Annexure A.
